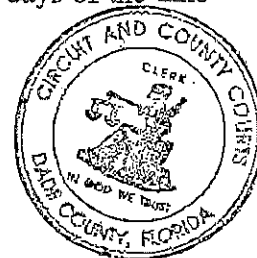

ORDER SEALING ORDERS INVOLVING SETTLEMENT AGREEMENT OF THE
PARTIES AND RECENT ANNUAL ACCOUNTING IN GUARDIANSHIP

This cause came before the court upon the court's sua sponte motion to seal, the court having considered the matter, it is

1. ORDERED and ADJUDGED that the guardianship issues is governed by the terms of a settlement agreement, entitled PRIVILEGED and CONFIDENTIAL SETTLEMENT AGREEMENT which contains a confidentiality clause that states as follows: complete confidentiality and sealing of settlement and related agreements and court approval.
2. The court directed the guardian's attorney to attach a copy of the settlement agreement to the inventory of the ward's assets, which needs an amendment.
3. Counsel for the guardian shall comply with the order to show cause which order to show cause shall also be sealed, consistent with the parties' settlement agreement. Counsel shall attach to an amended inventory (with the overdue audit fees) a signed copy of the settlement agreement of the parties entered into on December 2, 2006.

4. The Clerk of the Court is hereby directed to seal immediately the following:
5. The court's order dated October 27, 2009, and the order to show cause dated November 4, 2009.
6. It is further ordered that any materials sealed pursuant to this order shall be conditionally disclosed upon the entry of a further order by this court finding that such opening is necessary for purposes of judicial or governmental accountability or First Amendment rights.
7. It is further ordered that any materials sealed pursuant to this order may otherwise be disclosed only as follows:
 - a. To any judge of this circuit for case-related reasons;
 - b. to the Chief Judge or his or her designee;
 - c. to adult parties or their attorneys of record; or
 - d. by further order of the court.
8. It is further ORDERED that the Clerk is hereby directed to post a copy of the attached Notice of Entry of Order Authorizing Sealing on the Clerk's and Court's websites for a period of fifteen (15) days and to affix a copy of the order on the outside of the court record.
9. It is further ordered that the Clerk of the Court is hereby authorized to unseal any materials sealed pursuant to this order for the purpose of filing, microfilming or imaging files, or transmitting a record to an appellate tribunal. The materials shall be resealed immediately upon completion of the filing.
